- Please call (815) 459-7400 to schedule an appointment.
 If you are being treated for a medical condition, require antibiotic pre-medication or are taking aspirin or blood thinners, please inform the receptionist.
- After you have scheduled an appointment, please:
 - Register online at www.lehmanmenis.com
 - Click on the forms tab
 - Complete all the forms and click "Submit" to download the forms into our system.
- On the day of your appointment, please bring:
 - This sheet.
 - Any x-rays that your dentist has given you.
 - Any medical and dental insurance cards you may have.
 - A list of all medications with dosages that you are taking.
- If you are going to have sedation or general anesthesia (going to sleep):
 - Do not eat or drink anything for at least 8 hours before your appointment.
 - An adult must accompany and stay with you at home afterwards.
 - Minors (under the age of 18) must be accompanied by a parent or legal guardian.**
 - Please wear loose clothing, preferably with short sleeves.
- If you are unable to keep your appointment, please call (815) 459-7400 at least 24 hours before your appointment to reschedule.

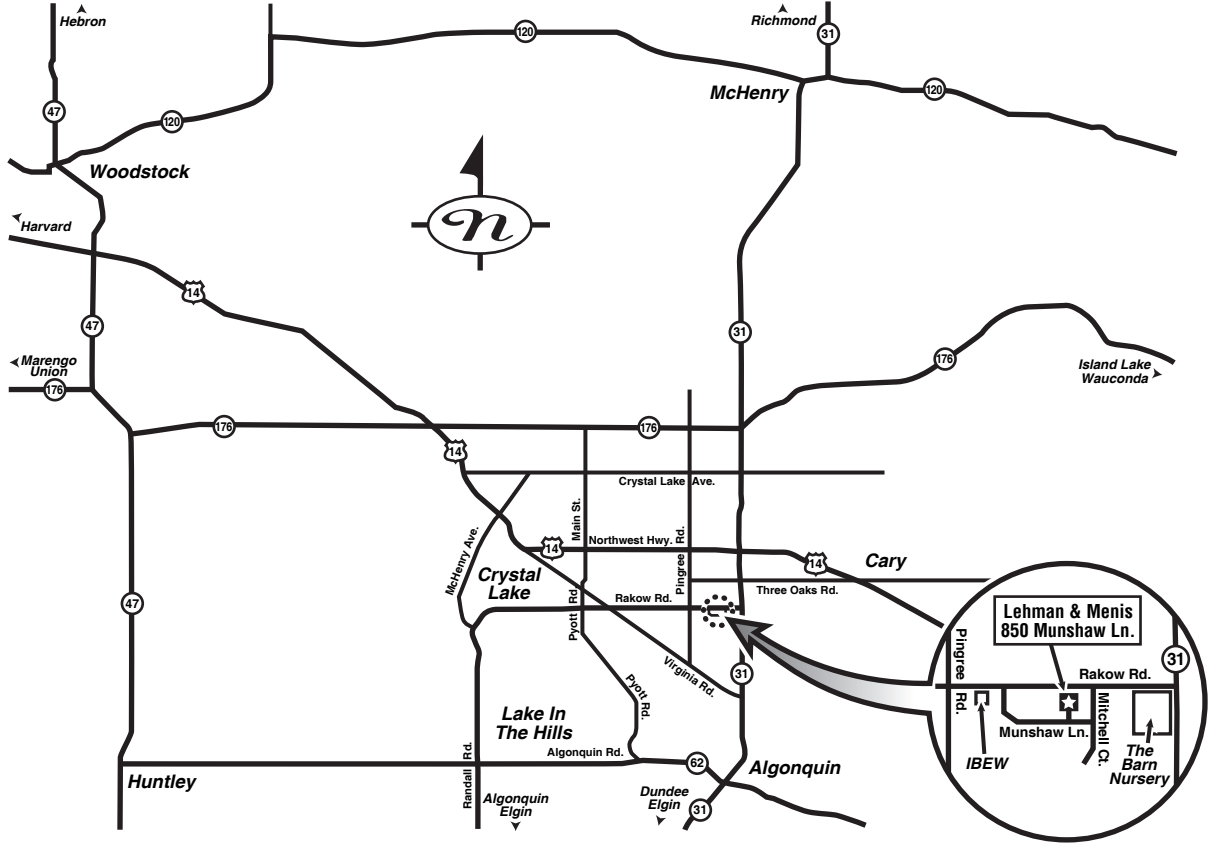
